- The adhesive sheetings may only be used if applied on rigid flat surfaces

- The plates are made of electrolytic zinc coated sheet steel or of (uncoated) aluminium
- The yellow retroreflective material is Reflexite Rear Marking Plate Material D73-6542 or Reflexite VC70 Am.1
- The red fluorescent material is Verni 503365 or Rethiocal 53822 or KIWACAL FL-603
